EUROPEAN TRAVEL INFORMATION AND AUTHORISATION SYSTEM

New entry requirement for visa-free travellers to enter the 27 Schengen countries, Bulgaria, Cyprus and Romania for a short stay.

- Starts in the first half of 2025
- ETIAS travel authorisation required to travel to 30 European countries
- **EUR 7 fee** (age: 18-70)
- Valid for **3 years** or until the passport expires













ETIAS IS NOT A VISA!

IT IS A TRAVEL AUTHORISATION FOR **VISA-EXEMPT TRAVELLERS** TO ENTER **30 EUROPEAN COUNTRIES**

Only for short stays (90 days in 180 day period)

Through pre-screening:

- Facilitates border crossings of travellers
- Detects those who could pose a risk







CHANGES AFFECTING TRAVELLERS

- Travellers must obtain their travel authorisation before starting the trip
- Status can be checked online
- No ETIAS = no boarding, no entry
